ALBERT CARMAN FONDS. - 1851-1917. - 2.9 m of textual records.

Albert Carman (1853-1917) was a Methodist minister and leader. He was born in Iroquois, Ontario, in 1833. He entered the Methodist Episcopal Church in Canada as a probationer in 1857; was ordained a Deacon in 1859; and became an Elder in 1863 and a Bishop in 1874. At the time of Methodist union he was elected one of the General Superintendents of the new Methodist Church (Canada). He retired in 1914 and was made General Superintendent Emeritus, and died in 1917.

Fonds consists of general correspondence, 1852-1917; Chown-Carman correspondence, 1904-1914; subject files, 1893-1913; pamphlets and newspaper clippings re Higher Criticism, sermons, addresses, accounts, appointments and notebooks/journals.

Rev. Albert Carman, M.A., D.D., L.L.D.



Albert Carman was born in the village of Iroquois, Dundas County, Ontarior on June 27, 1833, the sone of Philip Carman and Emmaline Shaver. His grandparents were United Empire Loyalists, and his father was a man of influence and standing in his own community, where he held positions of honor and responsibility. Philip Carman's three sons each achieved distinction in their various walks in life: Dr. Albert Carman in the Church; Judge Carman in the legal profession; and the third brother as a physician in Western Canada.

Albert Carman had a vigorous mind, a dominating will and a strong physical constitution. His early education was obtained in the public and grammar schools of his native town. In 1855, he graduated from Victoria College at Cobourg, (B.S.). In 1860, he received his M.A. from Victoria. Subsequently he received the degree of Doctor of Divinity from his Alma Mater, and in 1905, Northwestern University at Chicago granted him the degree of Doctor of Laws. In July, 1860 he married Mary Sisk.

Upon his graduation in 1855, he became head master of the County of Dundas Grammar School at Iroquois, and remained there until 1857, when he was elected Professor of Mathematics at Belleville Seminary. Subquently he became principal of that institution, and under his guidance, it became Albert College. Through his instrumentality, the College was affiliated with the University of Toronto in 1860, receiving in 1866, a university charter in Arts, and in 1868 a charter in all of the faculties. Albert University continued its work until the Methodist union of 1884, when it merged its university powers with Victoria and became a secondary school.

Dr. Carman was received as a probationer for the ministry of the Methodist Episcopal Church in Canada in 1857 and was ordained deacon in 1859 and elder in 1863. In 1874 he was elected bishop of that Church and held this office until the Methodist union of 1883-4. During his episcopate, the Church made rapid progress, due in great measure to cutstanding ability. MIssionary work was commenced on the Prairies, Alma College at St. Thomas was founded, and many impressive church buildings were constructed in towns and cities of Ontario. The educational level of the ministry was raised; fine gothic churches were erected and the old protracted meetings started to fall into disuse.

Dr. Carman was a key figure in the movement which brought about the Methodist Union of 1883-4 (see The Bulletin No. 19, 1967, Committee on Archives of the United Church of Canada). At the time of the union, he was elected one of the two General Superintendents of the new Church, and remained in office until 1914. For many of these years, the Church had only one General Superintendent, Dr. Carman. He filled the office with dignity and ability, and made the Methodist Church a great power in the life of Canada.

At the General Conference of 1914, he was appointed General Superintendent Emeritus, at his own request. Shortly afterwards he fell while a passenger in a street car in Ottawa, and did not recover from the broken hip he received. He died November 3, 1917.



Dr. Carman was an able and powerful speaker; he was a conservative in theology, who had a great concern for theology. After his demission of the office of General Superintendent, Canadian Methodism became less and less concerned about theology, and more concerned about social redemption. It would seem safe to say that it was never the same power afterwards that it had been at the height of Carman's Superintendency. Dr. Carman never hesitated to condemn publicly corruption in society or in government, but he believed firmly that a just society could only come from people who were converted Christians. He had no time nor patience with those who said that theology did not matter. He inherited a very high doctrine of the Church and the Ministry from the old Methodist Episcopal Church in Canada, in contrast to that held by groups such as the Primitive Methodists and the Bible Christians. While he was not able to impart this to the Methodist Church, Canada, as a whole, it always coloured his own thinking.

He played an important part in working for the proposed United Church of Canada, and was a firm believer in the desirability of such a Church to meet the religious needs of Canada.

Dr. S.D. Chown said of him: "In the days of his strenght Dr. Carman showed that he had learned how to lay down his life in service — perhaps in too arduous service". He was a man of great intellectual ability, and one of the greatest Churchman the Canadian Methodist Church ever possessed.






