UNITED CHURCH OF CANADA COMMITTEE ON ARCHIVES AND HISTORY FONDS: 1886-2014. --8.6 m of textual records. --84.8 mb of photographs.

Upon formation of the United Church in 1925, a Historical Committee (whose name changed in 1932 to the Committee on Archives) was given responsibility to preserve the records of the Church, albeit with no provision for a repository or a permanent archivist. The Committee's role was strengthened in 1940 when Victoria University agreed to serve as the repository for the Church's records; in 1953 the first full-time Archivist-Historian was appointed. The Archives occupied various places on the Victoria campus; in 1972 the Central Archives moved into the former Birge-Carnegie Library, which had been renovated to house the Archives. The Committee continued its dual role of operating the Central Archives, and coordinating archival activities across the Church. In 1978 the name was changed to the Committee on Archives and History. The Committee remained a standing committee of the General Council and was accountable to the General Council for the co-ordination and promotion of archival and historical activity for the United Church and all its Conferences, and for policies affecting the same. The committee was composed of an appointed membership. As part of the remit implementations and restructuring of the United Church of Canada courts in 2018, the Permanent Committee on Archives and History was dissolved.
